I agree to abide by all safety rules. I agree to listen to all instructions and to read and obey all posted safety rules.

I acknowledge that I must obtain permission and be under direct supervision of a certified belay instructor at all times in order to participate in ANY climbing activities. These instructors seek to create a safe environment by giving adequate warnings and/or instructions.

I warrant that I am in good health, physically fit, and have no physical conditions that would prevent me from participating in indoor rock climbing.

I acknowledge that the Glenfir Indoor Rock Climbing Wall requires the wearing of a helmet, suitable running or climbing shoes, and harness.

I acknowledge that Glenfir reserves the right to remove any participant judged unsafe or objectionable to others.

I FULLY UNDERSTAND THAT:

With the full knowledge that indoor rock climbing can be a dangerous activity which involves risks and even dangers of serious bodily injury, and that these risks and dangers may be caused by my own actions, or inaction, the actions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the "Releasees" named below, and that there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time, and I fully accept and I assume all such risks and all responsibility for losses, cost and damages I incur as a result of my participation in the activity attendant thereto, and thus release, and agree to indemnify and save and hold harmless, waiver and forever discharge, The Glenfir School and its officers, directors, employees, agents, volunteers, administrators, other participants, etc. (Each considered one of the "Releasees" herein" from any and all liability, responsibility and/or property damage, losses damages, claims, demands or causes of actions against them arising from or attributable to my participation in the "Glenfir Indoor Rock Climbing Wall" activity, I also release, waive, discharge, and relinquish anybody associated with the "Glenfir Indoor Rock Climbing Wall" including, any sponsors, volunteers, advertisers, and if applicable, owners and leasers of premises on which the Activity took place, any involved public entity, and their respective owners, officers, employees, agents, representatives, successors, and assigns (Each considered one of the "Releasees" herein) from any and all liability, responsibility and/or property damage which I sustain during my participation in any "Glenfir Indoor Rock Climbing Wall" event or activity.
